Cyrus Habib represents Bellevue, Kirkland, Redmond, Medina, Clyde Hill, and the Points Communities in the

Washington State Senate. In 2012, Habib was elected to the Washington State House of Representatives, making him the first and only Iranian American Elected Official to hold a state office in the United States. Habib was recently named one of the "40 Under 40 Political Rising Stars of 2014" by the Washington Post and was named one of "12 State Legislators to Watch in 2014" by Governing Magazine. Habib was elected by his Senate colleagues to serve as whip in the Democratic Caucus leadership team.
